



Fund IRL Survey Sweepstakes

Official Rules

NO PURCHASE, PAYMENT, DONATION, OR CONTRIBUTION NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Sponsor

The Fund IRL Survey Sweepstakes ("Sweepstakes") is sponsored by the **Connecticut Network for Children and Youth** ("Sponsor"), located at 415 Silas Deane Highway, Wethersfield, CT 06109.

2. Eligibility

The Sweepstakes is open to legal residents of the United States who are at least eighteen (18) years of age at the time of entry.

The following individuals are not eligible to participate:

- Employees, officers, directors, and agents of the Sponsor
- Immediate family members (spouse, parent, child, sibling, and their respective spouses) of the individuals listed above
- Persons living in the same household as such individuals

The Sweepstakes is void where prohibited by law.

3. Sweepstakes Period

The Sweepstakes begin on **September 14, 2026** and end at **11:59 PM Eastern Time on October 31, 2026** ("Sweepstakes Period").

Entries received after the Sweepstakes Period will not be eligible.

4. How to Enter

To enter, participants must:

1. Complete the Fund IRL Survey in its entirety; and
2. Submit the survey during the Sweepstakes Period.

Limit **one (1) entry per person**. Multiple entries from the same individual may be disqualified.

Participation in the survey is voluntary.

5. Prize Drawing

Five (5) winners will be selected in a random drawing from all eligible entries received during the Sweepstakes Period.

The drawing will be conducted on or about **November 7, 2026** by the Sponsor or its designated representative.

Odds of winning depend on the total number of eligible entries received.

6. Prizes

Five (5) prizes will be awarded.

Each prize consists of:

- One (1) **\$100 gift card**

Approximate Retail Value (ARV) of each prize: **\$100**

Total ARV of all prizes: **\$500**

No cash substitution, transfer, or assignment of prizes is permitted except by the Sponsor, which reserves the right to substitute a prize of equal or greater value if necessary.

7. Winner Notification

Potential winners will be notified using the contact information provided with their survey submission.

If a potential winner:

- Cannot be contacted within seven (7) days;
- Fails to respond within the specified time period;
- Is found to be ineligible; or
- Declines the prize,

the Sponsor may select an alternate winner through an additional random drawing.

8. Taxes

Winners are solely responsible for any federal, state, and local taxes associated with acceptance and use of a prize.

9. Publicity Release

Except where prohibited by law, acceptance of a prize constitutes the winner's consent to the Sponsor's use of the winner's name, city, state, likeness, and statements for promotional purposes without additional compensation.

10. Privacy

Information collected in connection with the Sweepstakes will be used for administration of the Sweepstakes and in accordance with the Sponsor's privacy practices. Survey responses may be analyzed and reported in aggregate form. Personally identifiable information will not be publicly disclosed except as required for prize administration or by law.

11. Release and Limitation of Liability

By participating, entrants agree to release and hold harmless the Sponsor and its officers, directors, employees, volunteers, and agents from any liability, loss, injury, or damage arising out of participation in the Sweepstakes or acceptance, possession, use, or misuse of any prize.

12. General Conditions

The Sponsor reserves the right to cancel, suspend, or modify the Sweepstakes if fraud, technical failures, or any other factor impairs the integrity or proper functioning of the Sweepstakes.

The Sponsor reserves the right to disqualify any individual who tampers with the entry process or violates these Official Rules.

13. Governing Law

The Sweepstakes and these Official Rules shall be governed by the laws of the State of Connecticut, without regard to conflict-of-law principles.
